

# ***Forever Wild Program Acquisitions***

1. **MONSANTO TRACT** in Marshall County consists of 209 acres of donated mountainous, pine-hardwood covered peninsula on Lake Guntersville that is being managed as both an extension of Guntersville State Park and to provide nesting habitat for the growing local population of Bald Eagles.

Mgmt. Objectives: Habitat conservation (Bald Eagle habitat), outdoor recreation, scientific research and education

2. **WEHLE TRACT** in Bullock County consists of 1,505 acres of rolling pine hills and hardwood branch bottoms that will be used for public recreation and a nature preserve. Approximately 640 acres are included for public hunting in the adjacent Barbour County Wildlife Management Area. This purchase involved a discounted sale, whereby the landowner voluntarily sold the tract for 50% of the appraised value.

3. **COON CREEK TRACT** in Tallapoosa County consists of 320 acres of a pine-hardwood creek valley on Yates Lake that is being managed for a public recreational site, a nature preserve and an environmental education study area.

Mgmt. Objectives: Habitat conservation, outdoor recreation (including public hunting), scientific research and education

4. **GRAND BAY SAVANNA TRACT** in Mobile County consists of 2,734 acres of coastal marsh and flatwoods, just onshore of the Gulf of Mexico that is being managed as a Nature Preserve.

5. **RIGGINS TRACT** in Lowndes County consists of 624 acres in a mosaic of upland and bottomland hardwoods, pine plantations and open fields on gently rolling alluvial land within Alabama's black belt. The tract is being managed for public hunting, along with other federal and state land acquisitions in the area, as part of the Lowndes Wildlife Management Area.

6. **FORT TOULOUSE TRACT** in Elmore County consists of 254 acres upland pine-hardwood forest land along the Alabama River that has a long natural history that includes the development of Native American cultures, the interaction between Indian and European cultures and the development of the State of Alabama.

7. **INDIAN MOUNTAIN TRACT** in Cherokee County consists of 514 acres of mountainous upland hardwood forest land along a route which will permit the connection of the Pinhoti Trail in the Talladega National Forest of Alabama with the southern terminus of the Appalachian Trail in Georgia. These lands were purchased in partnership with The Conservation Fund.

8. **BLAKELEY ADDITION TRACT** in Baldwin County consists of 420 acres of upland pine-hardwoods and bottomland hardwood forests on hilly land at the edge of the Mobile Delta marshlands. In addition to the wild, undeveloped landscape there are also several historical features to interpret and recreational opportunities to take advantage of. This tract has been used by prehistoric Indian societies, European pioneers, early American settlers, Civil War soldiers and generations of farmers.

9. **BLOWING SPRINGS CAVE TRACT** in Lauderdale County has cave habitat that is vital to the threatened gray bat. This 59.1 acre property will be preserved primarily to protect the existing and future population of this species at this location.

10. **BIG CATS CREEK TRACT** in Madison County consists of 197 acres of mountainous upland hardwood forest land on the eastern edge of Huntsville that is being managed as an addition to Monte Sano State Park.

11. **COLDWATER MOUNTAIN (Dedicated by Forever Wild Resolution as the Doug Ghee Nature Preserve and Recreation Area) TRACT** in Calhoun County consists of 3,924 acres of a high, pine-hardwood covered mountain along Interstate Highway 20 that casts its shadow onto portions of Anniston and Oxford. The tract secures a large portion of the local watershed for Coldwater Spring, a unique ecological environment and source of drinking water for local municipalities.

12. **PIKE COUNTY POCOSIN TRACT** consisting of 186.23 acres supports two unique plant communities: an uncommon scrub-hardwood/longleaf pine/reindeer moss vegetation type and an unusual evergreen plant community occurring in deep ravines on the site.

13. **EAGLE ROOST VIEW** in Marshall County is 17 acres of steep, mixed pine-hardwood covered property between Alabama Highway 227 and Guntersville State Park. The tract provides 2,000 feet of frontage for watching eagles across Town Creek Canyon.

14. **SIPSEY SULLIVAN TRACT** in Tuscaloosa County is 2,998 acres of bottomland hardwood forest and swamp lands along the flood plains of the Sipsey River. The Tract will be managed for public outdoor recreational and educational opportunities.

15. **MOBILE-TENSAW DELTA TRACT** in Baldwin and Mobile Counties is comprised of 35,531 acres of bottomland hardwoods, cypress/tupelo swamps, bogs, marshes and a variety of other wetland habitat types interspersed amid abundant water ways of rivers, creeks, sloughs, ponds and lakes. These lands are managed for public hunting and habitat conservation within the Upper Delta Wildlife Management Area.

16. **RUFFNER MOUNTAIN ADDITION TRACT** in Jefferson County consists of 227 acres of mountainous pine-upland hardwood forest land contiguous to the grounds and facilities of the Ruffner Mountain Nature Center. This tract, surrounded by the densely populated greater Birmingham metro area, provides tremendous opportunities for environmental education and outdoor recreation.

17. **BAYOU CANOT TRACT** in Mobile County consists of 1,933 acres of various wetland habitats in the west-central portion of the Mobile-Tensaw Delta; just south of Interstate 65. A \$1,000,000 grant from the North American Wetlands Conservation Program facilitated this purchase of unique habitats essential for avian conservation, as well as several rare species of plants and animals.

18. **INDIAN MOUNTAIN - GARNER TRACT** in Cherokee County consists of 80 acres of mountainous upland hardwood forest land along a route which will permit the connection of the Pinhoti Trail in the Talladega National Forest of Alabama with the southern terminus of the Appalachian Trail in Georgia. This tract serves as an addition to acquisition #7, which concludes purchase of all tracts originally nominated for this project. This tract was purchased in partnership with The Conservation Fund.

19. **SALCO AND MIDDLE RIVER TRACTS** in Mobile County consists of 1,764 acres of various wetland habitats in the west-central portion of the Mobile-Tensaw Delta; just north of Interstate 65. A \$1,000,000 grant from the North American Wetlands Conservation Program supported this purchase of unique habitats essential for avian conservation, as well as several rare species of plants and animals.

20. **LAUDERDALE AND FREEDOM HILLS WMA TRACT ADDITIONS** in Northwest Alabama. This 31,414 acre acquisition provides for 21 tracts that serve as public land additions to two Wildlife Management Areas which have been experiencing recent declines in acreage due to loss of leased land: 8 tracts totaling about 5,114 acres in Lauderdale County and 13 tracts totaling about 26,300 acres in Colbert County.

This acquisition was assisted by funds secured through the Environmental Section of the Alabama Attorney General's Office.

This tract serves as an addition to the property acquired in 1996, all of which is being managed as a Nature Preserve.

- 25. MOBILE-TENSAW DELTA - MCMILLAN 1 TRACT** in Baldwin County consists of 181 acres wetlands dominated by flood prone hardwood timber lying between Tensaw River and Tensaw Lake. A \$1,000,000 grant from the North American Wetlands Conservation Program supported this purchase of unique habitats essential for avian conservation, as well as several rare species of plants and animals.

- 26. THE BILLINGSLEY McCLURE SHOAL CREEK PRESERVE** in Lauderdale County consists of approximately 298 acres. Habitats across the site include fallow fields, mature upland hardwood stands and scenic creek bottoms. Waterways consist of Indian Camp Creek, Lawson Creek, Jones Branch, and Shoal Creek. This tract was purchased, in-part, through a \$100,000 Land and Water Conservation Fund grant awarded by the Alabama Dept. of Economics and Community Affairs, as well as financial and in-kind contributions from the City of Florence and Lauderdale County.

A \$1,000,000 grant from the North American Wetlands Conservation Program supported this purchase of unique habitats essential for avian conservation, as well as several rare species of plants and animals.

- 28. SIPSEY RANDOLPH TRACT** in Tuscaloosa County consists of approximately 153 acres dominated by flat river bottomland, and is bisected by old Highway 82 on the north end. The Sipsey River traverses the northwest corner of the property. The property adjoins the original Sipsey River Swamp tract acquired in 1999, and provides the public with a new point of road and river access to these state lands. This tract was purchased, in-part, through a \$60,000 conservation award from Ducks Unlimited, Inc.

The remainder of the tract was acquired by the State Lands Division through Coastal Impact Assistance Program funds, provided through the U.S. Department of Commerce's National Oceanic and Atmospheric Association (NOAA).

The tract is being managed as a nature preserve to forward the conservation of these rare natural communities. The remainder of the tract was acquired by the State Lands Division through Coastal Impact Assistance Program funds, provided through the U.S. Department of Commerce, National Oceanic and Atmospheric Association (NOAA).

This addition to the Coldwater Mountain tract was secured through a 2:1 acre property exchange. The Forever Wild Land Trust Board approved the exchange of 141 acres for the McCartney Tract's 280 acres. This addition provides alternate access to the now 4,063 acres of public land the tract.

The tract is comprised of mountainous and wooded terrain, hosting caves, springs, rocky bluffs and portions of the headwaters of the Paint Rock River. The tract is adjacent to Skyline Wildlife Management Area, on its western boundary.

These tracts, which are largely comprised of forest and marsh wetland habitats, were acquired with financial support from the U.S. Fish and Wildlife Service, through a \$1 Million National Coastal Wetlands grant. In partnership with the Alabama Forestry Commission, the Alabama Forest Resource Center and the Forever Wild Program, an additional 659 acres of upland forest habitat were acquired by the State Lands Division through a \$2.9 Million U.S. Forest Service Forest Legacy grant.

The tract adjoins the Splinter Hill Bog-Ben May Tract, and is being managed as a Nature Preserve to forward the conservation of these rare natural communities. The remainder of the tract was acquired by the State Lands Division through Coastal Impact Assistance Program funds, provided through the U.S. Department of Commerces National Oceanic and Atmospheric Association (NOAA).

The tract is cooperatively managed with the Black Warrior Cahaba Rivers Land Trust, the City of Pinson, and local citizens groups supporting the conservation of the Turkey Creek Watershed.
